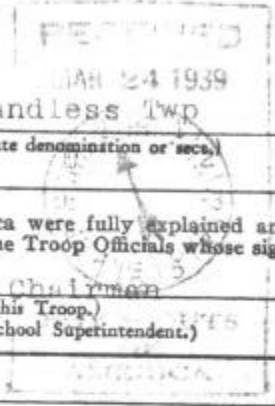

We recommend that they be commissioned as such and further agree that if for any reason the Scoutmaster ceases to serve we will notify the Local Council having jurisdiction over this Troop and endeavor to find a suitable successor; meanwhile we will assume control of this Troop.
